At the end of the Final, on Sunday the 09th of September, the engine and all relating accessories disassembled must be returned to the Vorton staff in the parc fermé. The engine and all accessories must be returned clean and in the same conditions in which they were delivered (undamaged).

After returning the engine, the Vorton staff will check its status (including all relating accessories), reserving the right to charge any costs of repair / replacement of spare parts to the Applicant for breakage or failure, for improper care and missing maintenance of the kart or for damage caused by improper use of the engine or damage caused by an accident. Below is the chart with all the pieces and prices.

At the time of delivery of the engine, you will have to show an identity document, which will be held as guarantee and will be given back when the engine will be redelivered.

The Applicant declares to understand, accept and respect the conditions of hire above mentioned.

The Applicant hereby agrees to bear the cost of any repairs or replacements of the engine parts according to the prices shown in the chart below.

Disclosure in compliance of art. 13 of the European Regulation 679/2016

Pursuant to art. 13 of the European Regulation (EU) 2016/679 (hereinafter GDPR), and in relation to the personal data which the Company will be given, we inform you as follows:

Data controller and responsible for the protection of personal data

The Data Controller is OTK Kart Group S.r.l. (also referred to as "Company"), in the person of its legal representative pro-tempore, with registered office in Prevalle (BS), via dei Soprini, 16, tax code no. 01899940173 and VAT no. 00663270981. The Data Controller can be contacted at info@vortex-rok.com The Company has not appointed a person responsible for the protection of personal data (RPD or, data protection officer, DPO).

Purposes of data processing

With the express consent of the interested party, the Company will process the personal data collected, giving them also to those Parties indicated in this information sheet, for the management and realization of the sporting event. The data may be used for the drafting of rankings and for the publication of video-photographic material of the sporting event.

Legal basis of data processing

The Company processes your personal data lawfully, where the data processing is:

- is deemed necessary for the execution of the requested service;
- is imposed by legal obligations;
- is based on the express consent.

Consequences of failure communication of personal data

With regard to the personal data requested, the failure to communicate them, prevents the execution of the service.

Methods of data processing and storage

The information and personal data collected will be used and stored in order to provide the requested service. Once the service is complete, all personal data will be destroyed within 10 years.

Personal data will be processed by the data controller using partially automated and/or non-automated tools; personal data are stored on servers with limited access.

Data communication

Your personal data may be disclosed to:

- 1. Companies controlled and/or connected to OTK Kart Group S.r.l.;
- 2. consultants who provide functional services for the purposes indicated above;
- 3. people related with the management of the event, such as Marshalls and organizers;
- 4. banking and insurance bodies providing functional services for the purposes indicated above;
- 5. people processing data for specific legal obligations;
- 6. Judicial or administrative authorities, for the fulfillment of legal obligations.

Data reporting and distribution

Your personal data are not subject to any fully automated decision-making process, including the report of data.

Your data may be published on the internet www.vortex-rok.com website, or other means of communication (eg. press releases), together with the ranking data, photographs and other data related with the sporting event, within the limits, for the purposes and extent specified in the disclosure.





Rights of the interested party

Among the rights acknowledged by the GDPR you are allowed to:

- ask the Company for access to your personal data and information related; the amendment of incorrect data or the integration of incomplete data; the cancellation of personal data concerning you (in case one of the conditions indicated in article 17, paragraph 1 of the GDPR occurs and in compliance with the exceptions provided for in paragraph 3 of the same article); the restraint of the processing of your personal data (on the occurrence of one of the hypotheses indicated in Article 18, paragraph 1 of the GDPR);
- request and obtain from the Company in the cases in which the legal basis of the treatment is the
 contract or consent, and the same is performed by automated means your personal data in a format
 structured and readable by an automatic device, also with the aim of communicating such data to
 another data controller (so-called right to the portability of personal data);
- oppose at any time the processing of your personal data in case particular situations occur;
- revoke the consent at any time, limited to the cases in which the processing is based on your consent for one or more specific purposes and includes common personal data (for example date and place of birth or place of residence), or particular categories of data (eg. data revealing your racial origin, your political opinions, your religious beliefs, your health status or your sex life). The treatment based on consent and carried out prior to its revocation preserves, however, its lawfulness;
